POSSIBLE ACTION Presentation and request for funds from Makers on 5th and Clinton Culinary business incu-Economic Growth bator: Economic Growth Corporation Vice President, Beth Payne, and CEO, Brian Hollen-back, explained their funding request for \$50,000 to continue development of the incubator spaces in the Wilson Loft development. The request is tenant specific as there is a need for dry and cold storage space for both retail and restaurant incubators Irwin asked if they had reached out to CCDA with a request. Payne indicated that they had reached out to them. Srp said he needs to make sure that the request qualifies under the criteria that we operate under and if so, are there resources available to proceed. Irwin said that possible resources could be Economic Development or ARPA funds. Srp said he would schedule a meeting with County Auditor Eric Van Lancker to see what is available as it is becoming increasingly difficult to allocate becoming funds for requests like this, especially with House File 718. George asked for the ARPA funds discussion to be added to the next Board meeting agenda. Irwin said they would review the possibility of funding and add an-other discussion to the January 22 Board of Supervisors agenda. County Master Plan update: Clinton County Planning and Zoning Director Thomas Barnes and Dan Fox, ECIA, explained that the County Master Plan has not been updated since 1997. Barnes said with the discussions that came from the solar projects, he felt an update projects, he felt an update should be done. Fox said Barnes had contacted ECIA, requesting help with updating the master and comprehensive plan. Fox said he put together a draft of what work and cost estimate for the project. He explained that it is a 12-month process, looking at major issues that affect growth and development in the county. He said it involves public meetings, surveys and the appointed steering committee. Irwin said that Barnes previously reached out to the organization that did the County previous plan but did not receive any response. He said Barnes had a conversation with ECIA, who responded immediately. Fox said they are looking at next fiscal year timeframe should the county want to proceed with the project. Srp asked what the benefit of this project is to the county, as it is not a free project and with the current financial decisions. there a need to do this at this time. Barnes said the plan is a guide to how we want to see the county in the future. Fox said the benefit of the plan is not just having the plan, but the process that it goes through to map out where the county wants to be in the future. Barnes said the estimated cost of the project is not to exceed \$50,000, split 50/50 between the county and ECIA. Srp asked about the date when the county would have to commit to the project. Fox said ECIA would need to know early July or early fiscal year so they can block out space on their project schedule. Irwin said they will add the request for funding the project to the budget discussions for FY25.
