Since its passage, the misinformation on this bill has been rampant, spread by city and county administrators and officials who either misunderstand the bill or are choosing government spending over taxpayers.

If a city or town is not experiencing growth, the tax levy adjustment mechanism, which is the tool used to help control the growth of spending and property taxes, does not impact their budgeting ability.

HF 718 was a large bill, but local governments haven't even gone through a budget cycle yet to truly see how it will affect their finances.

The bill will not cut money from any local entity. It only slows how fast and how much it grows, similar to how the state budget has only grown 2-3% each year since Republicans have been in the majority.

We are always happy to have a conversation about legislation and how we can improve a property tax system ranked 40th out of 50

This past week I have been in meetings where we have discussed re-structuring the HHS budget bill and improving the delivery of mental health care in Iowa. We have also been looking into some of the details of Reynolds' Governor proposals.

is now available on Iowa Finance Authority's website. The program provides an Iowa tax credit for agricultural asset owners to lease their land, equipment, and/or buildings to beginning farmers. Applicants to the program must be a resident of Iowa, 18 years of age and have a net worth of no more than \$833,000. Applicants must have sufficient education, training, or experience for the anticipated farm operations and have access to adequate working capital, equipment, and other items that are necessary to operate the farm.

Applications for the program are processed on first-come, first-completed basis and will be accepted until August 1, or until all the tax credit allocation has been awarded. More information can be found at https://www.iowafinance.com/ beginning-farming-programs/ **Time for Tax Returns**

The IRS recently announced that Monday, Jan. 29, 2024, is the official start date of the nation's 2024 tax season and the agency will begin accepting and processing those 2023 tax returns. An estimated 128.7 million individual tax returns are expected to be filed by the April 15, 2024, tax deadline.

Despite opening day not being until the 29th, most software companies accept electronic submissions and hold them until the IRS is ready to process. IRS Free File will also be available on IRS.gov starting Jan. 12. Some of the new and expanded tools from the IRS this tax filing season include:

Extended hours at many taxpayer assistance centers nationwide.

Increased help available on the toll-free line and an expanded customer call back feature designed to significantly reduce wait times.

An enhanced IRS Individual Online Account that includes chat, the option to schedule and cancel future payments, revise payment plans and validate and save bank accounts.

money. The romantic cheats are

criminal deadbeats. They will seem genuine because they have created a fake online identity and use social engineering to prey on potential victims. That means they do their homework to profile their target so they are able to take advantage of someone's vulnerability, generosity or empathy. They manipulate and endear themselves to build an illusion of trust and affection over a period of time.

Some scammers even propose marriage. Sooner or later, they will ask for money or trick you into making an investment. They may ask for gift cards or cash to buy a plane ticket to come for a visit, or to pay for medical expenses or other life emergency. They may pretend to be in the military and appeal to your sense of patriotism.

According to data from the Consumer Sentinel Network, Americans filed nearly 70,000 reports of romance scams in 2022 with financial losses reaching \$1.3 billion. As with any romantic situation, online or in person, it's better

to be safe than sorry.

For example, if a new love interest asks for your bank account information, date of birth or Social Security number, let that raise a red flag. End all contact before the scammer is able to ghost you after taking your money and stealing your

Q: How can people protect themselves and report fraud?

A: First, don't be ashamed. Fraud can happen to anyone. If you suspect identity fraud or a romance scam, file a police report and contact your financial institutions to protect your

Ask credit bureaus to monitor your identity for suspicious activity or put in place a security freeze.

Report the suspicious activity to the FBI's Internet Crime Complaint Center. Be prepared to share records, such as emails, addresses, phone numbers, financial transactions and receipts.

When using social media, be wary of messages from people you don't know. Tighten your privacy settings.

Scammers harvest posts and profiles to build an online relationship with their target to seem like it's a match made in heaven. Digital hustlers also

will use flattering compliments, pretend to share acquaintances and interests to ingratiate themselves with their targets. They're looking to hook someone into building an online relationship.

Be guarded about the information you share online. Also tread cautiously if the person wants to switch gears and move your conversation from where you first met to continue on a private messaging board. Criminal imposters are looking to cover their tracks. Also be mindful that a request for explicit photos is an invitation for extortion. Don't do it.

If an online romance partner won't meet in person, keeps asking for money and sounds too good to be true, trust your gut instinct. Confide in a trusted friend or family member to help protect yourself from a broken heart and an empty bank account.
